BIOSECURITY PROMULGATION 2008
(PROMULGATION NO. 28 OF 2008)

**Biosecurity (Fees and Charges) (Amendment)
Regulations 2015**

PURSUANT to section 15(2) of the Biosecurity Promulgation 2008, the Biosecurity Authority of Fiji hereby makes these Regulations—

Short title and commencement

1.—(1) These Regulations may be cited as the Biosecurity (Fees and Charges) (Amendment) Regulations 2015.

(2) These Regulations shall be deemed to have come into force on 20th October, 2011.

Schedule amended

2. The Schedule to the Biosecurity (Fees and Charges) Regulations 2011 is deleted and substituted with the following—
