

BIOSECURITY ALERT ON THE IMPORTATION OF ANIMAL PRODUCT

AMENDMENT TO BAF'S IMPORT REQUIREMENTS FOR PERSONAL IMPORT OF SHELF STABLE NUTRITIONAL SUPPLEMENTS, INFANT FORMULA, CONDENSED MILK AND EVAPORATED MILK


Warning:

Biosecurity is your responsibility. Heavy Penalties apply. If in doubt, declare it.

Biosecurity Authority of Fiji (BAF) has reviewed the import of shelf stable nutritional supplements, infant formula and condensed milk for personal consumption from selective countries into Fiji. Restrictions will remain for importation of other dairy products from any country into Fiji.

Shelf-stable food is food that can be safely stored at room temperature in a sealed container. This includes foods that would normally be refrigerated but which have been processed so that they can be safely stored at room or ambient temperature for a long shelf life.

Selected country list



An import permit is not required when importing the following dairy products and supplements into Fiji from the above listed countries under personal allowance (10kg/22.04lbs).

1. Shelf stable Nutritional Supplements: an import permit is not required when importing nutritional supplements into Fiji from the above listed countries.



2. Shelf stable Condensed & Evaporated Milk: an import permit is not required when importing condensed and Evaporated milk into Fiji from the above listed countries.



3. Shelf stable dairy base Sports supplements: an import permit is not required when importing dairy based sports supplements into Fiji from the above listed countries.



4. Shelf stable dairy base Infant formula: an import permit is not required when importing dairy based infant formula into Fiji from all the countries.



Passengers are not allowed to import products containing dairy as ingredients other than above products from the above listed countries.

Please note

The products must be:

- Shelf stable:
- Commercially prepared and sealed packed;
- In its original packaging on arrival;
- 10kg /22.04lbs of collective weight; and
- With original retail receipt from above listed countries.

The Products must have the labeling on the package in the English language and must;

- State country of origin; and
- Have the ingredient list with composition of each ingredient.
- All dairy products of Australia, New Zealand and France origin are allowed as previously practiced.
- BAF allows the importation of infant formula per individual person from all countries. Product (s) must meet all
 other requirements as stated above.
- BAF allows importation of nutritional supplement with dairy under medical ground for the therapeutic purpose from all countries only if it is accompanied by medical letter from medical practitioners stating usage of particular nutritional supplement (s) for a medical condition. Product (s) must meet all other requirements as stated above.

The **products containing Dairy/ Animal ingredients must be declared** and consignments are subject to inspection at port of entry, the border and post-border for biosecurity purposes.
