BIOSECURITY ACT 2008

**Declaration of Biosecurity Emergency Areas for –  
Tongan Fruitfly for Yasawa Group and Mamanuca  
Islands**

*(Bactrocera facialis)*

IN exercise of the powers conferred on me by section 77 of the Biosecurity Act 2008, with the advice of the Biosecurity Authority of Fiji and in consultation with the National Disaster Risk Management Council, I hereby declare the area of the Yasawa Group and Mamanuca Islands identified in the Schedule as a biosecurity emergency area for Tongan Fruitfly (*Bactrocera facialis*).

This Declaration is in force for a period of 6 months from the date of publication in the Gazette.


Any movement of mango (*Mangifera* spp.), guava (*Psidium* spp.), papaya (*Carica papaya*), citrus (all spp.), avocado, breadfruit, starfruit, rose/malay apple (*Syzygium* spp.), capsicum, tomato, pumpkin, zucchini, cucumber, melons (*Cucurbita* spp.), and other host material identified by the Biosecurity Authority of Fiji, is prohibited. Host material includes all fruits found in Yasawa Group and Mamanuca Islands.

Pursuant to sections 79(3) and 94 of the Biosecurity Act 2008, any person who contravenes any direction made pursuant to this Declaration commits an offence and is liable to the penalties prescribed under Schedule 5 to the Biosecurity Act 2008.

## Biosecurity Emergency (Tongan Fruitfly) (*Bactrocera facialis*) Regulations 2025

IN exercise of the powers conferred on me by section 80 of the Biosecurity Act 2008, on the advice of the Biosecurity Authority of Fiji, I hereby make these Regulations—

*Short title and commencement*

- 1.—(1) These Regulations may be cited as the Biosecurity Emergency (Tongan Fruitfly) (*Bactrocera facialis*) Regulations 2025.
- (2) These Regulations come into force on the date of publication in the Gazette.

*Interpretation*

2. In these Regulations, unless the context otherwise requires—

“Act” means the Biosecurity Act 2008;

“Declaration” means the Declaration of the Biosecurity Emergency Areas for Tongan Fruitfly (*Bactrocera facialis*) made pursuant to section 77 of the Act;

“host material” means any fruit within the infected zone; and

“person” includes a company or association or body of persons, corporate or unincorporated.

*Restriction on movement*

- 3.—(1) Where an area has been declared as a biosecurity emergency area pursuant to section 77 of the Act for Tongan Fruitfly (*Bactrocera facialis*)—

- (a) personal carriage of any host material of the Tongan Fruitfly (*Bactrocera facialis*) out of the area;
- (b) the movement of any host material of the Tongan Fruitfly (*Bactrocera facialis*) within the area without prior authorisation from the Authority; and
- (c) personal carriage of any host material of the Tongan Fruitfly (*Bactrocera facialis*) within the area without prior authorisation from the Authority,

is prohibited.

- (2) Any person who fails to comply with subregulation (1) commits an offence and is liable on conviction to a fine not exceeding \$40,000 in the case of an individual or \$200,000 in the case of a body corporate.

*Supplementary powers of biosecurity officer*

4. A biosecurity officer may—

- (a) enter any farm or any land area, including a dwelling house without warrant to ascertain whether or not any host material on the farm or land area is infected with Tongan Fruitfly (*Bactrocera facialis*);

- (b) take the necessary containment measures to decrease the risk posed by the infestation of the Tongan Fruitfly (*Bactrocera facialis*);
- (c) treat any infested fruit, plant, by way of chemical treatment to contain the spread of Tongan Fruitfly (*Bactrocera facialis*);
- (d) destroy any fruit, which he or she reasonably believes to be severely infested with Tongan Fruitfly (*Bactrocera facialis*) and is a major biosecurity risk that cannot be adequately contained or mitigated through treatment or other control measures; and
- (e) inspect any baggage, vehicle, cargo, and premises within the biosecurity-controlled area.
